P 2533 Election of Committee Chairman (Cllr Marshall in the Chair)

Cllr Paul Avis proposed and Cllr Fiona Stimpson seconded that Cllr Mike George be elected as Committee Chairman. There were no further nominations for the post.

Public Forum

P 2537 Horley NE Sector

Cllr Denese Brooke Harte addressed the Council in a personal capacity. She explained that she had taken specific interest in the passage of transport to and from the new estate when acting as a member of the Town Council's Transport Sub-Committee. She explained that the Sub-Committee had considered parking matters, buses etc and, in particular, had emphasised

P 2537) that the new link road to the A23 road must be constructed first to allow cars to access the new estate. Cllr Brooke-Harte stated that she had received many complaints from residents living on the Langshott estate who were angry and she added that she felt that the Borough Council had broken its promise and was allowing Langshott to be blighted by traffic from the new estate, when she had sincerely believed that only buses would be allowed access to or from the estate, via Langshott Lane..

Mr Neil McAllister addressed the Council regarding his concerns about public safety in the underpass from the High Street to Station Road. He spoke of his concern after an attack in March when a woman was robbed in the tunnel. Mr McAllister urged the Council to support his petition so that important enhancements could be made such as CCTV, better lighting, white paint on walls, improvement to drains, mirrors at blindspots.

P 2548 The meeting considered the address by Cllr Denese Brooke Harte at the Public Forum. It was noted that Cllr Olliver had made his own researches and had concluded that it was his understanding that, as far as the roads and bus layouts for Lanshott were concerned, plan ref: P/04/01778/DET13 showed the junctions in Phase 1 and the right and left turns in Phase 2. All junctions in Phase 1 were fully accessible and had only 'Give Way' signs. He believed that the misunderstanding was in the Decision Notice which mentioned 'Bus Only' access to Langshott in one of the summary pages but also mentioned access roads. He agreed that the paragraph was not at all clear.

RESOLVED: that the matter be deferred to the next meeting of this Committee so that the matter can be further clarified with Borough Council Officers.

P 2550 Airport Matters – GATCOM Meetings and Updates
