**P 1626     Horley Anderson Swimming Pool**

Members discussed at length the recent press report on the Borough Council's alleged intention to close the Horley Anderson Swimming Pool in 2008 without a new facility in place.

Cllr Miller stated that he sat on a Borough Council committee which reviewed all leisure facilities and he understood that a confidential report would be made available to the Executive Committee on 19 January 2006. Cllr Miller believed that no decision had yet been made but understood that there was pressure to provide both indoor and outdoor leisure facilities in Horley, especially as Horley had an increasing population and was the only town in the Borough which would have section 106 funding available from the Horley Master Plan. Cllr Miller stated that, in his opinion, Horley should have a "head start" over any other area in the Borough. Other members commented that the alleged comments made by Cllr Kay, regarding K2 in Tilgate, Crawley, were not helpful and that we should seek to obtain Cllr Kay's views on the matter directly. Cllr Diana Andrews believed that the facility of a swimming pool in Horley was absolutely vital as it had particular significance for young people in providing safety, confidence and general fitness.

The Clerk reported that the matter had been covered in general detail in our letter to RBBC sent in November 2005. A reply had been received from Graham Cook, Director of Services to the Community which referred to this important project and stated that the Town Council was a key stakeholder and would be involved in the consultation process. It was agreed that a further letter should be written to Graham Cook to emphasise the Town Council's concerns over the recent press speculation and to ensure a seamless change

**P 1626)** when the Anderson Centre was eventually closed. It was also requested that further reference should be made to the original options for discussion (namely redevelop Horley Anderson, utilise Oakwood School, and seek clarification of the prospects for the new leisure centre in the Court Lodge grounds now occupied by the football club and lastly the Bonehurst Road site).

Members also agreed that a letter be sent to Cllr Allen Kay to clarify that the costs had been quoted correctly.

**P 1627** ***RESOLVED: that the Clerk write to Graham Cook, Director of Services to the Community to seek clarification on the above matter and to follow up on the Borough Councils' comments as stated in their letter of November 2005. (A copy is appended to these minutes.)***

**P 1628** ***RESOLVED: that the Clerk write to Cllr Allen Kay seeking clarification of his views on the recent press article regarding the use of K2 (Crawley) and the need, or otherwise, for wet leisure facilities in Horley. (A copy is appended to these minutes.)***
