#### **Contracts**

Any contract which is made between the Member and/or relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority:

(a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

Any beneficial interest in land which is within the area of the relevant authority.
