A23 Recreation Ground


Skate Park installed in January in conjunction with several sponsors and consultation with the youth group, G Force. Additional lighting and a new path have also been installed.

The Annual Public Meeting of Horley Town took place on Monday 22nd April 2002 at Oakwood School.

All Horley residents were entitled to attend. Those who attended took part in a lively discussion period.

As well as the reports given by Committee Chairman, topics such as the impact of a 2nd runway at Gatwick Airport, the options for the pedestrianisation of the Town Centre, and the threat to Victorian properties in Horley were discussed.

Youth Council

The Town Council is liaising with Horley youth organisations to evaluate whether a Youth Council can be formed.

This is an ambitious project in its infancy, and exploratory discussions are taking place with other councils to select the best format. The Council will try and involve young people in the future planning and development of their town.

We shall keep everyone informed of the progress made.

Freedom of Information Act

The Town Council has adopted the Model Scheme of the Parish Council FOI 2000.

This means that any resident may ask to see a variety of council documentation ranging from council minutes, accounts to audit reports.

If you do want to view any documentation please contact the Clerk to the Council.

Town Council and Young People

The Town Council is determined to improve facilities for young people within our Town. Young children are well catered for with recreational needs in all our playgrounds, which are maintained to high standards at all times.

Our playground equipment is regularly inspected and repaired or replaced as required. Equipment is regularly updated but always within the confines of the L&A budget. In the last few years we have

focussed on providing facilities for teenagers. Notably we successfully sought funding from Reigate & Banstead Borough Council, Gatwick Airport and others in order to provide a skate park in the A23 recreation ground.

The Town Council provided additional funding for the Youth Bus to visit on a regular basis. This project provides an alternative evening venue for those who do not belong to "established" youth clubs.

We are mindful of the need for a drop in centre/coffee bar and would be supportive of any reasonable initiative to deliver this.

We also provide additional funding for the Detached Youth Worker project. This scheme enables qualified youth workers to go out to the young people themselves. They advise on the effects of anti-social behaviour, sexual problems, drug issues and other concerns.

HIGHLIGHTS in brief....

Horley Master Plan

In 2001 the Inspector published his report. This took into account all the comments submitted. HTC took a lead role in co-ordinating evidence on behalf of the "Horley Alliance".

The Council submitted its own written responses, employed a flood consultant to present all the evidence collected on flood risk,

This evidence caused the Inspector to place the Local Plan on hold pending further work by the Environment Agency to validate the flood model, and produce a map of the flood plain in which the public could be confident.

Gatwick Expansion

The Planning & Development Committee responded to the White Paper, "The Future Development of Air Transport in the United Kingdom: South East" This document recommended that there should be no additional runways at Gatwick.

Horley Town Council supported this recommendation and was pleased that the Government intended to abide by the Legal Agreement which prevents a second runway before 2019.

A subsequent challenge by Kent and Essex County Councils to include Gatwick was successful and the issue is to be revisited by the Government.

New Waste Strategy

Horley Town Council are supportive of the unified waste strategy, promoted by Reigate & Banstead Borough Council, Mole Valley and Tandridge District Councils recognising the need for businesses, residents and all concerned to reduce waste and increase recycling.

Vandalism in Town Council Playgrounds

You may be aware about the recent spate of vandalism in our playgrounds and recreation parks. The Council have taken a number of measures to prevent mindless damage, the cost of which has had to be borne by the local taxpayer.

We liaise very closely with Surrey Police, and have undertaken a number of preventative measures.


