

Horley to benefit from the estate of Cyril Edmonds

Members of Horley Town Council discussed the Cyril Edmonds Will at its Full Council meeting on 6 November 2007. As announced last July, the Town Council has been left a substantial sum of money by Mr Cyril Edmonds, a builder who lived at Norwood Hill.

It is believed that the capital value of the bequest will be in excess of £130,000. It has been agreed that the sum will be held in a specific fund maintained separately from the Town Council's general fund.

A sub-committee was formed earlier in the year to look into the matter and make recommendations to the Town Council as to how to make best use of the funds. Its brief was to satisfy the terms of the will, which had

stated that the bequest "should be used for the benefit of the people of Horley as a whole".

Full public consultation was conducted via press releases, articles in the Town Council's newsletter and on its website. Many members of the public have been in contact with the Council to make a number of interesting suggestions. The Council also listened to presentations made at its public forum on 6 November.

The Council agreed with the sub-committee's recommendations that the capital sum be placed in a high-yielding account and that the interest derived from it be used for the benefit of underprivileged and needy Horley residents. The interest, which could amount to

£6,000 per annum in a full year, is expected to be utilised for outings, theatre trips, booking of holidays, etc. The matter will be reviewed annually and reports will be presented at the Annual Town Meeting. Other specific projects using the capital may be considered in future years.

A separate Management Committee has been set up (consisting of Cllrs Simon Marshall, Michael Miller and David Powell) which will be empowered to consider applications from the public.

Further details of the scheme will be announced in due course.

Environmental

Art Day at Emlyn Meadows



An Environmental Art Day was held at Emlyn Meadows last October. A total of eleven local schools showed exhibits and sculptures, which had been created by their pupils following tuition from environmental artist, Alan Sage. The exhibits were then shown at all participating schools throughout the following week.

The event was funded by Awards for All, a lottery grants scheme for local communities, and hosted jointly by Gatwick Greenspace Partnership, Horley Town Council and the Horley Learning Partnership, an organisation which liaises with local schools.

Emlyn Meadows, which is owned and managed by Horley Town Council, is an area of meadow and woodland adjacent to Kingsley Road. The Gatwick Greenspace Partnership has worked jointly with the Town Council to advise and help create a nature trail and sustainable environmental area.

Art Matters

Art Matters is a studio in Horley providing support, space, materials and a calming atmosphere for those experiencing mental health needs. It is part of the Richmond Fellowship, and is based at the Gatwick Metro Centre in Horley but is currently looking for new premises for the project.

One in four people will experience emotional and mental distress in any year and social exclusion factors compound the issue. Creative activity has long been recognised as beneficial to those experiencing mental health issues, promoting relaxation and reducing stress. The opportunity to interact with like-minded individuals in a safe and calm environment like Art Matters can also help reduce feelings of isolation and loneliness

Cllr Simon Marshall visited the studio last October with members of his family and friends. He created his own 'sand mandala', tried his hand at silkscreen printing and contributed to a piece entitled 'One in Four'.

The Mayor was presented with a sand mandala kit and a 'voucher' for a sand mandala workshop, giving the opportunity to a community group of the Mayor's choice to experience and learn more about this ancient creative tradition.

In the photos Cllr Marshall contributed to a painting entitled 'one-in-four', a visual representation of the statistic that one in four people will at some time in their life have mental health needs. With artist Howard, he is also seen working on a word mandala, a circular pattern which is made up from thousands of quotations.

Council approves Expenditure Budget and sets Precept for 2008/2009

At its Full Council meeting on 15 January 2008, Horley Town Council approved its budget for 2008/2009 and set the Town Precept for a total net figure of £278,560 (compared to the net figure of £269,376 for 2007/08). Cllr Michael Miller, Chairman of the Town Council's Finance & General Purposes Committee, explained that the town element of Council Tax would be £32.59 representing an annual increase of 69p per Band D household (+ 2.16 per cent).

Cllr Miller explained that the Town Council was committed to its programme of enhancements for the coming year, as detailed in the Corporate Plan. These would include improvements to recreation grounds and the substantive refurbishment of the Albert Rooms community hall, funded by a loan from the Public Works Loan Board. Cllr Miller commented that the Town Council had made considerable effort to structure projects on three year rolling programmes wherever possible. This had allowed the annual increase to be kept within reasonable levels. The increase of 2.16 per cent compared favourably with the Annual Retail Prices Index (RPI) increase of 4.3 per cent and the annual Consumer Price Index (CPI) of 2.1 per cent, announced in November 2007.

It was noted that the Town Council would continue to support St Bartholomew's two churchyards and will make a grant of £12,500 towards its grounds maintenance.


Charges for community facilities (such as the use of the Albert Rooms and football pitches) will be increased in line with inflation for the coming year.

Prudent use of Council finances has allowed the Council to use £20,000 of its general reserves towards next year's costs. The Town Council also has a duty to provide for future likely expenditure and is therefore increasing its earmarked funds by £30,000 for football pitches, playgrounds and community projects.

The Town Council has recognised the need to improve security in its recreation grounds and has increased its budget for CCTV enhancements. These will be carried out in consultation with Surrey Police. There will also be a commitment for regular security patrols in all the Town Council's parks and outside areas, to ensure the safety of all members of the public. The Council has made a provision for floral displays in the town centre in support of our proposed entry for South and South East in Bloom 2008, having successfully achieved a silver award in 2007. Sponsorship from local businesses will also be sought.

This Council will continue to seek funding from appropriate bodies. To date we are preparing a substantial bid to the Football Foundation for work on our football pitches at Court Lodge. Other funding has been generously offered from our local Borough and County Councillors' Initiative Schemes.

Recreation Parks Update

The council has decided to upgrade the CCTV cameras in the parks. You may have noticed that the Charlesfield Road entrance to the Horley Recreation Ground has improved lighting. This is new white light technology which we using on a trial basis. This will enable improved recognition for our cameras and will make the park even safer for everyone.
