The Town Clerk reported that, as non-essential shops begin to open again and in support of the RBBC campaign to 'Shop Safe, Shop Local' residents will see social distancing signs and markings placed in Horley to help shoppers navigate the 'new normal' of the high street. Social distancing remains essential to the safety of shoppers, and it is hoped that these markers will help to keep the message at the forefronts of people's minds. Visitors to the high street can expect to see all new signs and markings in place by the end of June.

CEO Update to GATCOM Members on the Covid-19 Impact on Gatwick's Operation

The communication had previously been circulated to all Members for information. The Town Clerk gave a brief overview of the content, including the reference to the long-term prospects for Gatwick Airport. The Chairman added that the next GATCOM meeting in July would now be a virtual meeting. He also referred to the impact of the reduced Gatwick Airport activity on the local economy and residents in terms of redundancies, reduced hours and amended contracts. The impact would be far reaching outside of the immediate area as every job at the airport, was supported by three- four jobs nationwide. Current predictions suggested that it would most likely take until 2023/24 for Gatwick to return to 2019 level.
