C 4007 Public Forum

A member of the public expressed concern at the planned move of Horley Library to the Russell Square site, as he believed that the site was considerably smaller than the existing library site. Cllr Olliver responded that he believed the site was considerably bigger than had been described in a recent newspaper article. Cllr Jackson confirmed that the area currently used by the library would be accommodated at the proposed site. Cllr George explained that this was one of four possible sites which had been considered by Surrey County Council in recent years. The freehold of the Russell Square site was owned by Reigate & Banstead Borough Council and the site would be offered to the County Council on a 998 year long lease ("virtual freehold"). Cllr Samantha Marshall confirmed that a meeting of representatives of the County Council and the Horley Local History Society was to
