C 3331 Himalayan Balsam Action Plan

Cllr Powell reported that, following areas being flailed and litter picked, local farmer Simon Court had now sprayed approximately 5,000 square metres of the eastern bank of the River Mole with herbicide, to eliminate Himalayan Balsam, brambles, stinging nettles etc. A few more patches would be sprayed at the end of the month and in early July volunteers would be sought to pull up any plants which remained. Cllr Powell added that he had attended a course which now enabled him to spray both on water and on land. Simon Court was contacting farmers on the opposite bank of the Mole and this very steep area was likely to need treating from a boat. Grant funding from Borough and County Councillors had funded attendance at the spraying course and the equipment needed. Japanese knotweed had also been identified which would be dealt with by the Environment Agency. Cllr Powell reminded members that this was all part of a seven year plan to eliminate the Balsam.
