**L 5629 HTC Grounds Maintenance and Security**

The Leisure Officer gave the following updates:

- **Contractor Meetings:** Routine grounds maintenance by Idverde and parks contractors remains satisfactory.
- **Members' Inspection Reports:** A report of cannabis smoking in the undergrowth, near the boundary with the Horley Tennis Club, was noted and the Leisure Officer will forward the details to the local policing team.
- **Maintenance and Repairs:** Coordination is underway to address rusty gate safety concerns at the Bowls Club rear entrance together with the cracked flagstones at the Court Lodge playground entrance.

**L 5630 Community Events in Horley**

The following updates were received:

- **Horley in Bloom (HIB):** The competition awards evening has been rebranded as the "Horley Awards Night" with a focus on wildlife-friendly gardening. Entries are open until 25 September.
- **Horley Carnival:** Preparations are progressing smoothly for 20 June with live music and youth groups confirmed.
- **Other Matters:** The 'Africa Day' community event is set for 30 May 30 and a football event is scheduled for 6 June.

**L 5631 Community Projects Update**

The Leisure Officer gave the following updates:

- The new outdoor gym equipment at Court Lodge and Michael Crescent, funded from **the RBBC CIL SIP 2 Allocation**, has been signed off and fully delivered.
- The new outdoor gym equipment and surfacing, funded from the Surrey County Council Your Fund Surrey scheme, has likewise been signed off.
- The replacement windows at the Innes Pavilion and planting around building, covered by the **RBBC CIL SIP 2 Allocation**, have been completed.

- The replacement roof windows at the Innes Pavilion, funded through the Leisure Committee's Earmarked Fund, have also been completed as an additional project delivered by the Town Council.

**L 5632 Skatepark Graffiti Project – Horley Recreation Ground**

The Leisure Officer reported that a new art project described as a graffiti wraparound design at the skatepark is under consideration as a joint project with Oakwood School, 'Growing Health Together' and the Town Council. A grant of £1,500 towards the artwork has been secured through a generous contribution from 'Growing Health Together'. An additional £600 contribution towards the project is required from the Leisure Earmarked fund (HTC) to pay for liaison officers to work with at-risk individuals from Oakwood School and in order for the artwork themes to be considered. The Committee unanimously supported the project and a contribution of £600 to be made. A further update on progress would be provided at the next Committee meeting.
