P 5157 Proposed Horley Business Park

Three representatives of the Keep Horley Green Campaign were in attendance. Joanna Barnett told members that their online petition, opposing the proposed Horley Business Park, had received over 4,000 signatures. A video on the "Keep Horley Green" Facebook page, showing the extent of the recent flooding on the site with the use of a rowing boat, had attracted around 38,000 viewings so far.

Standing Orders were suspended by the Chairman so that the matter, listed as a separate item on the Agenda, could be brought forward to that part of the meeting.

The residents were told that the matter had been discussed at RBBC's Full Council meeting in December. The Key Messages from this meeting had been published on the Borough website together with answers to frequently asked questions regarding the proposed Horley Business Park.

P 5157) The Committee Chairman explained that Horley Councillors had met with senior Borough Officers in December, where it had been explained that, should the proposals go ahead, this would be a very slow process. Much was still to be determined. A Communications Consultant had been appointed and an outline Planning Application was expected later in 2016.

Cllr Olliver said that the Town Council was unable to give an opinion regarding the proposed development until a formal Outline Plan was in place. Cllr Powell added that a full environmental audit would also be essential at an early stage. It was noted that the Proposed Horley Business park was now a standing item on the agenda of the Town Council's Planning Committee and Cllr Olliver gave assurance that members would take great interest once more formal information was available.
