## **Highways Matters**

# P 4781 SCC Consultations: Local Transport Review Extended Deadline: 2 February 2015

Members discussed the proposals contained in the SCC Local Transport Review to reduce its expenditure on local bus services, community transport/concessionary travel, and the following suggestions were made:

- To restrict the issue of a Bus Pass to senior citizens and disabled passengers.
- To assess a Bus Pass application for travelling companions individually, as many disabled passengers may commute unaccompanied.
- To restrict concessionary fares for travelling companions to a set number of trips per year and manage through a voucher system.
- To offer a reduced rate for travelling companions (similar to child or student fares).
- To curtail the frequency of off-peak services, depending on demand.
- To introduce concessionary fares to attract workers from outlying employment areas into the town centre, at lunch times, to support the regeneration of the town centre, particularly food outlets.

The Chairman advised he would prepare a draft response on the Town Council's cost saving recommendations prior to the closing date, for ratification at the next Committee meeting.

## P 4784 Airports Commission Consultation: Proposed Second Runway at Gatwick Airport (Closing Date: 3 February 2015)

The Committee Chairman gave an overview of the preliminary draft response by the Town Council to the **Airports Commission Consultation** – **Proposed Second Runway at Gatwick Airport**, with reference to the following key issues:

- Surface Access;
- Flooding;
- Water Quality;
- Noise;
- Air Quality;
- Community Analysis;
- Local Economy; and
- Quality of Life.

In summary, the Town Council accepted that a second runway would bring economic prosperity for many who live and work in the South East. However, based on the results received from the extensive questionnaire, the majority view of local residents who were against the proposal for a second runway, had been endorsed.

The submission from the Town Council would (subject to final amendments) be forwarded to the Airports Commission prior the closing date, and ratified at the next Committee meeting.

Cllr Olliver expressed his sincere gratitude to Cllr George, on behalf of members, for his tremendous work and dedication in his review and preparation of the Town Council's response to the Consultation.
