Parking Obstruction: Kings Road, Horley

The Clerk advised that he had notified Surrey Highways about concerns affecting mobility scooters and wheelchair users, at Kings Road, Horley. He was later informed that the Parking Enforcement Team would investigate disabled access being seriously compromised at the location, when the lay-bys to the surgery were frequently blocked by parked vehicles, and if 'No Parking' signage as well as hatched lineage could be clearly displayed as a deterrent.  - **A** No confirmation received as yet but SCC Executive asked to clarify.
- Q4 Horley Subway: What was the latest update on Network Rail and Community Payback repainting and improving the Subway?
 - **A** SCC Highways asked to clarify, in conjunction with Network Rail.
- Q5 Horley Precinct: Would resurfacing of the pavement and provision of new street furniture be implemented shortly (further to comments made by SSEIB judges on the street scene)?
- **A** RBBC Executive approval would be required for project officers to be appointed on design and consultancy for a range of regeneration projects.

Standing Orders were then suspended so that further details from Cllr Tony Schofield (RBBC Executive Member for Planning & Development) could be heard.

Cllr Schofield clarified that RBBC Executives would, firstly, be asked to consider approval to progress a joint venture for the development of employment land in Horley (Agenda Item 6); and secondly, to obtain Executive and Full Council approval to progress a Compulsory Purchase Order (CPO) to support the development of employment land in Horley (Agenda Item 7).

It was noted that any such proposals must go out to public consultation first, and that many stages would follow including detailed Planning Applications. Members felt, however, that such proposals in principle for an area of open farmland in Horley to be considered commercially viable as a Business Park, should be supported.

(It was subsequently reported that at the RBBC Executive Meeting, the members supported the officer's recommendation for the use of Compulsory Purchase Order powers for the development of employment land in Horley.)
