P 4696 Apologies and Reasons for Absence

RESOLVED: that the apologies of Cllr Miller be accepted for reasons as specified in the Attendance Register.

P 4698 Public Forum

There were 7 members of the public present during the meeting.

Planning Applications : 14/02124/F & 14/02125/LBC: Landens Buildings, Meath Green Lane, Horley

A group of local residents addressed the Committee on the above proposal for refurbishment and conservation of existing farm buildings to 9 new dwellings, demolition of existing bungalow, other outbuildings and structures plus construction of 29 new dwellings with associated garaging, boundary treatments and landscaping.

There was also a separate Planning Application in respect of Listed Building Consent for demolition of outbuilding and removal of haha wall.

- **P 4698)** Each speaker, in turn, made representations to outline their objections on the grounds of:
 - **Development Issues** (including an unnecessary development which contravenes the Borough Local Plan on Affordable Housing).
 - Highways & Access Issues (including poor site access via a narrow lane and risk of high increase in traffic, which contravenes the commitment that the development in the North West Sector would not permit vehicle access on to Meath Green Lane).
 - Drainage Issues (including inadequate sustainable drainage to capture surface water and prevent sewage problems).
 - Wildlife Habitation Issues (including loss of wildlife on the site for which a Biodiversity Plan should be made to protect endangered species and their habitats).
 - *Historic Preservation Issues* (including risk of removal of ancient features such as haha wall).

The Committee Chairman expressed his thanks for the comments made, and Standing Orders were then resumed so that a formal response by the Town Council could be made.

RESOLVED: that the following comments be made regarding Planning Application: 14/02125/F – Landens Buildings, Meath Green Lane, Horley.

The Town Council OBJECTS on the following grounds:

- i) Overdevelopment.
- *ii)* Inappropriate and incoherent development;
- *iii)* Proposed access on to Meath Green Lane contravenes the Borough and Local Plan; and
- iv) Inadequate drainage.

We also believe that there should be an updated Biodiversity Plan in place as there could be protected species on this site.

RESOLVED: that the following comments be made regarding Planning Application: 14/02125/LBC – Landens Buildings, Meath Green Lane, Horley:

The Town Council OBJECTS to the demolition and loss of any historic buildings and features, and that these should be incorporated into the development (for example, Tanyard Barn, North East Sector).

North East Sector

P 4713 Langshott Allotments

The Clerk reported that the legal transfer of the Langshott Allotments was close to completion, and the tenancy agreements for the new allotment holders had already been prepared. It was, however, thought that the allocation of plots would not be until the New Year so that they may be marked out and ploughed first, and this work had been delayed following recent heavy rainfall.

P 4714 Phase 3, The Acres Development, North East Sector & Tanyard Barn

Cllr Schofield gave an update on Phase 3 of The Acres, North East Sector, advising that the developer had planned to put arrangements in place to speed up construction on the site, over seven days a week, in order to complete all of the outstanding works. The contentious issue of bus routing via Langshott Lane and Brookfield Drive, to enable such large vehicular access through the development, had yet to be resolved.

He also told members that the developer had put out to tender the conversion of Tanyard Barn into a community hall with specific contractors specialised in the conservation, restoration and repair of historic structures so that part of this listed building could be preserved.

P 4715 North West Sector

Cllr Schofield told members that the three remaining developers in the consortium had reached agreement following the land purchase at the

P 4716 Town Centre Regeneration

Railway Matters

P 4717 Network Rail Consultation – Draft Sussex Area Route Study Closing Date: 13 January 2015

Cllr George told members he had reviewed a lengthy study undertaken by Network Rail to identify a number of constraints across the rail network, in particular, over-crowding on trains into London Bridge and Victoria, during peak times. He had prepared a response in his capacity as GATCOM representative, and gave a summary on particular concerns for Horley with its population increasing and thereby having a direct impact on residents commuting to work into London.

P 4718 Govia Thameslink Railway Consultation – December 2015 Timetable Closing Date: 30.1.15

Cllr George reported receipt of a Consultation by Govia Thameslink, on a proposed Off-Peak Timetable for the New Franchise in 2015, and its plans for 108 new carriages on the Gatwick Express and Thameslink route, to replace the existing fleet. The proposed timetable changes would be to the off-peak Brighton Main Line service pattern to benefit passengers based south of London Victoria, London Bridge and London Blackfriars. In order to gather opinions from regular rail users on these routes into London via Horley, both Cllrs Spratt and Jackson volunteered to consider these on their forthcoming rail trips, and then provide constructive feedback to the Committee at a later date.

Highways Matters

P 4719 SCC Consultations: Local Transport Review

The Clerk reminded members that SCC's Group Manager for Travel & Transport, Paul Millin, would be giving a Local Transport Review presentation alongside his colleague, Val Sexton, in the Edmonds Hall, on 2 December, starting at 7.15 pm. Cabinet Member, Mike Goodman would also be present, and confirmed responses had been received from other neighbouring Council representatives as well.
